Caboose Ride Terms

1. Purchaser along with eight (8) guests is entitled to one (1) session consisting of a one (1) hour caboose ride on a Orrville Railroad Heritage Society caboose at the DABO facility located at 2174 S. Crown Hill Road, Orrville, Ohio 44667.
2. Application must be completed and submitted with payment.
3. ORHS reserves the right to cancel or reschedule any session as necessary.
4. Applications will be processed in the order in which they are received (first-come, first-served). Applications without prepayment will not be processed. In the event of a conflict with your chosen date and/or time, you will be contacted by an ORHS representative to either resolve the conflict or provide a refund.
5. Ride purchaser or their appointed representative must be present and part of the riding party. Party cannot be larger than nine (9) total participants. Lap children must be less than 2 years of age and will be counted as one of the party.
6. ORHS will provide one (1) car host for each session.
7. Ride purchaser assumes all liability during the session.
8. Restrooms are NOT available on the caboose. A portable toilet is on premise for use before and after session.
9. Pets or comfort/emotional support animals are not permitted on ORHS railroad equipment.
10. Please note that the caboose is vintage railroad equipment and is not ADA Compliant.
11. NO REFUNDS ON SESSIONS CANCELLED WITHIN 24 HOURS OF THE SCHEDULED SESSION.
