Get close and personal with the track and try your hand at running a speeder.

Then get close and personal with the track and try your hand at running a speeder. Speeders, officially known as motor cars or track cars, were used to haul personnel to remote locations for maintenance duties. Learn about how speeders work and take a spin down the track at the controls. Sessions are \$50, last about an hour and you can bring two guests along to ride with you. And, you get to pick your "ride". We have four Fairmont A4 speeders to choose from.

Operators must be at least 16 years old with a valid driver's license or photo ID. Knowing how to drive a 4-speed manual transmission is very helpful but is not necessary.

Session must be booked no later than midnight the day before your session. This allows us to get your chosen speeder ready.

Available dates: Throttle Time is typically scheduled on second and fourth weekends of the month. May 26 through October 6. Saturdays: 8:30AM (one hour session only); Sundays: 9AM, 10:30AM, Noon and 1:30PM. To inquire or schedule a session, please call the depot at (330) 683-2426 and we'll get back to you. Download and mail the order form to complete your order. After receipt of your order, we'll call you to confirm a date and time. Additional times may be made available by calling the Depot.

Throttle Time on the speeders is not available for online booking. The information and order form can be downloaded below.

Throttle Time Speeders Sessions Rules

1. Purchaser is entitled to one (1) session consisting of a safety and general operation orientation culminating in a minimum of 30 minutes of actual throttle time on one of Orrville Railroad Heritage Society's (ORHS) Speeders at the DABO facility located at 2174 S. Crown Hill Road, Orrville, Ohio 44667. Purchaser should allow up to one hour total for session time.
2. You will be contacted by a member of ORHS to arrange an appointment for your session. Session must be scheduled in advance and will be carried out at the convenience of ORHS and its operating crew members. Time slots are limited and may sell out. Scheduling starts on May 26, 2024. The session must be scheduled to occur no later than October 6, 2024.
3. ORHS reserves the right to cancel or reschedule any session as necessary.
4. ORHS reserves the right to refuse services to any purchaser deemed unfit for any reason for the sessions.
5. Long pants and closed toe shoes are mandatory. Work gloves are recommended.
6. Purchaser must be sixteen (16) years or older, have a current state ID or driver's license with a clean driving record and must be able to follow directions from the ORHS crew members.
7. Purchaser assumes all liability during the session.
8. Purchaser may transfer the session to another person of choice. However, that person must meet the same eligibility requirements stated herein.
9. NO REFUNDS ON SESSIONS CANCELLED WITHIN 48 HOURS OF THE SCHEDULED SESSION.

Please be advised that sessions will take place rain or shine on the scheduled date. If you are not contacted by ORHS within 15 business days of mailing, please notify the Depot office.
